5 Fire Fighting Measures

Suitable Extinguishing Media:

Use water fog (or if unavailable fine water spray), alcohol resistant foam, standard foam, dry agent (carbon dioxide, dry chemical powder).

Specific Hazards Arising from the Chemical:

Hazardous combustion products include oxides of carbon and oxides of nitrogen, smoke and other toxic fumes.

Stop leak if safe to do so. Wipe up with clean cloth or paper towels. Absorb large spills with sand, earth, vermiculite or some other absorbent material. Collect the spilled material and place into a suitable container for disposal.

7 Handling and Storage

Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of vapours. Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

Conditions for Safe Storage:

Store in a cool, dry and well ventilated area and out of direct sunlight. Keep container in an upright position, tightly closed when not in use. Protect from elevated temperatures and sources of ignition and heat. Keep away from oxidising agents and foodstuffs.
